Space is limited, and wording is subject to Executive Committee approval. Please note this is a preliminary plan. The Campaign Executive Committee will finalize a complete plan, which will honor and recognize all contributions of \$1,845 or more in total gifts. Pledged amounts may be paid over a three-year period.
